Since returning home to Canada, he has been diagnosed with Legionnaires' disease (http://www.cdc.gov/legionella/patient_facts.htm) and has developed severe symptoms. His case was so bad that doctors were unsure of his chances of survival during his initial hospitalization. The disease has completely changed his life and personality.

According to the Centers for Disease Control and Prevention, between 8,000 and 18,000 people in America are hospitalized each year with Legionnaires' disease.
